### IN BRIEF

- 104 high-level dignitaries and officials are expected to deliver statements during the fourday High-Level Segment of HRC58, which will take place in a hybrid manner. So far, a total of eleven heads or deputy heads of government, and 83 ministers or vice-ministers are scheduled to address the Council. Secretary-General of the United Nations, H.E. Mr António Guterres, Human Rights Council President H.E. Mr. Jürg Lauber, as well as the President of the UN General Assembly, H.E. Mr. Philemon Yang (Cameroon), will also be delivering an address at the start of the High-Level Segment.
- On **3 March**, Mr. Volker Türk, the UN High Commissioner for Human Rights, will open HRC58 with an **oral global update on the human rights situation around the world**. This oral update together with other country specific oral updates given by the High Commissioner will provide the basis for the general debate under item 2 on 3 and 4 March.
- During the session, the Council will consider country-specific reports the Hiah by Commissioner and the Secretary-General covering human rights issues in, inter alia: Cyprus; Guatemala; Honduras; Colombia; Occupied Palestinian Territory, including East Jerusalem; Sudan; Democratic People's Republic of Korea; Syrian Golan; Israeli settlements in the Occupied Palestinian Territory, including East Jerusalem, and in the occupied Syrian Golan; and Haiti.
- Concerning technical assistance and capacity building (item 10), the Council will consider **two reports by the High Commissioner** (one on

technical assistance and capacity-building (for South Sudan, and one technical assistance and capacity-building to improve the situation of human rights in Haiti, in connection with a request from the authorities of Haiti for coordinated and targeted international action), and will hear four oral updates/presentations by the High Commissioner (one on cooperation with and assistance to Ukraine in the field of human rights; one on cooperation with Georgia; one technical assistance and capacity-building in the field of human rights in the Democratic Republic of the Congo (DRC); and one on enhancement of technical cooperation and capacity-building in the field of human rights).

- Additionally, the High Commissioner will deliver oral updates on the human rights situations (items 2 and 4) in **Myanmar; Nicaragua; and Venezuela** (Bolivarian Republic of).

It will also consider the High Commissioner's and Secretary-General's reports on a number of thematic issues, including *inter alia*:

- Measures taken to implement Human Rights Council resolution 9/8 and obstacles to its implementation, including recommendations for further improving the effectiveness of, harmonizing and reforming the treaty body system (SG's report).
- United Nations Voluntary Fund for Victims of Torture (<u>SG's report</u>).
- Special Fund established by the Optional Protocol to the Convention against Torture

and Other Cruel, Inhuman or Degrading Treatment or Punishment (<u>SG's report</u>).

- Intersessional workshop on cultural rights and the protection of cultural heritage (<u>HC's</u> <u>report</u>).
- Human rights and transitional justice (HC's report).
- Question of the realization in all countries of economic, social and cultural rights (<u>SG's</u> report).
- Mental health and human rights (HC's report).
- Comprehensive study on the use of digital technologies to achieve universal birth registration (HC's report).
- Panel discussion on ensuring livelihood resilience in the context of the risk of loss and damage relating to the adverse effects of climate change for achieving progressively the full realization of all human rights and ways forward to address the challenges thereto on the basis of equity and climate justice (HC's report).
- Human rights dimension of care and support (HC's report).
- During the session, the Council will hold:
  - 22 Interactive Dialogues with Special Procedures mandate-holders, including 15 with thematic mandate holders dealing with counter-terrorism and human rights; right to food; freedom of religion or belief; adequate housing; effects of foreign

debt; sale, sexual exploitation and sexual abuse of children; human rights defenders; minority issues (two reports); torture and other cruel, inhuman or degrading treatment or punishment; rights of persons with disabilities; albinism; right to privacy; the human right to a clean, healthy and sustainable environment; and cultural rights; as well as **seven with countryspecific mandate holders** on the Islamic Republic of Iran; Myanmar; Democratic People's Republic of Korea; Afghanistan (two reports); and Mali.

- Five Enhanced Interactive Dialogues on: Eritrea; High Commissioner's report on Sudan; report of the Commission of Human Rights in South Sudan; OHCHR report on transitional justice; and oral update of High Commissioner and team of experts on DRC.
- Two Interactive Dialogues with the UN Special Representatives of the Secretary-General on violence against children and for children and armed conflict.
- Six Interactive Dialogues with Human Rights Council-mandated Investigative Bodies, including the Group of Human Rights Experts on Nicaragua; Independent International Fact-Finding Mission on the Islamic Republic of Iran; Independent International Commission of Inquiry on the Syrian Arab Republic; Independent International Commission of Inquiry on Ukraine; and the Group of Independent Experts on the Human Rights Situation in Belarus.

- In accordance with <u>HRC/PRST/OS/13/1</u> all the Interactive Dialogues will be individual.
- Based on the initiatives formally announced at the HRC58 organisational meeting, the Council is expected to act on around **28 draft resolutions**. The deadline for submitting draft resolutions has been set at **1:00 PM on Friday**, **21 March 2025**.
- The Council will also adopt the **UPR outcome** reports of 14 States: Albania, Bhutan, Brunei Darussalam, Costa Rica, Côte d'Ivoire, Democratic People's Republic of Korea, Democratic Republic of the Congo, Dominica, Equatorial Guinea, Ethiopia, Qatar, Portugal, Nicaragua, and Norway.
- Additionally, it is expected to appoint three vacancies of mandate holder: one member to the Expert Mechanism on the Rights of Indigenous Peoples (from Central and Eastern Europe, the Russian Federation, Central Asia and Transcaucasia); and two members to Expert Mechanism on the Rights of Indigenous Peoples (one from Central and South America, and the Caribbean and one from the Pacific). - Due to a UN holiday, no meetings will be organised nor technical support will be offered on Monday 31 March 2025.

### MODALITIES FOR THE 58TH SESSION

- The 58th session of the Human Rights Council will take place in Room XX.
- As of 22 January 2024, the Department of General Assembly and Conference Management at the United Nations Office at Geneva (UNOG) introduced restrictions relating to the management of official UN meetings and conferences, including restrictions on lunchtime meetings and the use of remote participation and hybrid modalities. Virtual live participation in meetings (e.g. on Zoom, Webex, Interprefy etc.) are not allowed, but prerecorded video statements are still accepted, of course alongside in-person participation. UN Web TV will also continue to livestream the Council's meetings. This follows the request from the Council to the General Assembly, through its April 2024 decision 55/116, to authorise the Council to continue using remote participation modalities.
- Following on from the previous Council session, informal negotiations, side events and other informal meetings taking place on the sidelines of HRC58 would be able to benefit from audio-visual services as well as the use of WebEx on a costrecovery basis.
- The online registration platform for the 58th session, 'Events,' can be found at: <u>https://events.ohchr.org</u>.
  - For <u>States</u>, inscription to the list of speakers via the 'Events' platform for all interactive dialogues and panel discussions will open on Monday, 17 February at 4 PM and will close

24 hours before the debate is scheduled to start. After the online inscription has closed, delegations may still inscribe or withdraw by sending an email to the address OHCHR-hrclistofspeakers@un.org. The list of speakers will close approximately 15 minutes after the beginning of each debate. For the adoption of UPR outcomes, States' registration for the list of speakers will open on Monday, 10 March at 9 AM and will close on Thursday, 13 March at 6 PM. No inscriptions will be possible after this deadline.

#### For national human rights institutions and non-governmental organisations:

<sup>°</sup> The list of speakers for oral statements during the session will open on Tuesday, 18 February at 2 PM and close at 6 PM. on the working day before the debate is scheduled to. NHRIs with 'A' status and NGOs with ECOSOC consultative status will have the possibility to deliver their statements in person or via pre-recorded video-statements for all debates (i.e., interactive dialogues, panel discussions, and UPR adoptions). Registration, indication of method of participation, and uploading of video statements will be through the 'Events' platform and the uploading of transcripts is mandatory irrespective of the method of participation. The deadline for all participants (whether in person or via video statement) to upload the transcripts and video statements with transcripts (as applicable) is 6 PM on the working day before the debate is scheduled to start, and will constitute confirmation of participation.

- The schedule of opening and closing dates for the online submission of NGO Written Statements at the 58th session of the Council will be as follows:
- Registration of NGO Written Statements for General Debates under all agenda items of the 58th session will open from Monday, 20 January 2025, at 12:00 PM CEST and close on Monday, 27 January 2025, at 12:00 PM.
- Registration of NGO Written Statements for the other debates under agenda items 1, 2, 3 and 4 (excluding General Debates) of the 58th session will open from Monday 27 January 2025, at 12:00

PM and close Monday, 3 February 2025, at 12:00 PM.

- Registration of NGO Written Statements for the other debates under agenda items 6, 9 and 10 (excluding General Debates) will open from Monday, 3 February 2025, at 12:00 PM and close Monday, 10 February 2025, at 12:00 PM.
- As in the previous sessions, the Secretariat has implemented a feature that allows NGOs to co- sponsor other NGOs' statements directly through the <u>online</u> <u>registration system</u>. The previous method, i.e. sending the co-sponsorship form via email, will no longer be accepted.
- The 58th session during Ramadan will be adjusted in the same manner as at the 55th session in March 2024. Namely, the meetings will be held from 9:30 AM to 12:30 PM and from 12:30 PM to 5:30 PM.



# MEASURES TO ASSIST SMALL DELEGATIONS DURING THE HRC

### PANEL DEBATES

HRC58 is scheduled to hold **nine panel discussions** on the following subjects:

- Annual high-level panel discussion on human rights mainstreaming on the theme "Thirtieth anniversary of the Beijing Declaration and Platform for Action" (24 February, <u>concept note</u>).
- Biennial high-level panel discussion on the question of the death penalty on the theme "Contribution of the judiciary to the advancement of human rights and the question of the death penalty" (25 February, <u>concept note</u>).
- Panel discussion on early warning and genocide prevention (5 March, <u>concept</u> <u>note</u>).
- Panel discussion on the realization of human rights in sustaining and increasing the gains made in the HIV response and leaving no one behind (6 March, concept note).
- Panel discussion on the realization of the rights to work and to social security in the informal economy (7 March, <u>concept note</u>).

- Annual interactive debate on the rights of persons with disabilities on the theme "Rights of persons with disabilities: digital and assistive technologies, countering cyberbullying, and digital inclusion" (10 March, <u>concept note</u>).
- Annual full-day meeting on the rights of the child. Two panels under the theme "Early childhood development" (13 March, <u>concept note</u>).
- Commemoration of the International Day for the Elimination of Racial Discrimination on the theme "Sixtieth anniversary of the adoption of the International Convention on the Elimination of All Forms of Racial Discrimination" (27 March, <u>concept note</u>).
