# IN BRIEF

■ More than 113 high-level dignitaries and officials are expected to deliver statements during the three-day **High-Level Segment** of HRC49, which will take place in a hybrid manner. So far, a total of two heads or deputy heads of State, five heads or deputy heads of government, and 73 ministers or vice-ministers are scheduled to address the Council. Secretary-General of the United Nations, H.E. Mr Antonio Guterres, as well as the President of the UN General Assembly, H.E. Mr Abdulla Shahid, will also be delivering an address at the start of the High-Level Segment.

■ On 7 March, H.E. Ms. Michelle Bachelet, the High Commissioner for Human Rights, will give **an oral update on the human rights situation around the world**. This will provide the basis for an interactive dialogue with the High Commissioner on 7 and 8 March.

■ During the session, the Council will consider **country-specific reports** by the High Commissioner and the Secretary-General covering human rights issues in, *inter alia*: Afghanistan, Colombia, Cyprus, Guatemala, Honduras, Myanmar, Nicaragua, Occupied Palestinian Territory, occupied Syrian Golan, and South Sudan. Additionally, the High Commissioner will deliver **oral updates** on the situations in Cyprus, Democratic People's Republic of Korea, Democratic Republic of the Congo, Eritrea, Sudan, Tigray, Ukraine, and Venezuela (Bolivarian Republic of).

■ It will also consider High Commissioner and Secretary General reports on a number of **thematic issues**, including *inter alia*:

- combating intolerance, negative stereotyping and stigmatization of, and discrimination, incitement to violence and violence against, persons based on religion or belief;
- comprehensive approach to promoting, protecting and respecting women's and girls' full enjoyment of human rights in humanitarian situations;
- contribution of respect for all human rights and fundamental freedoms to achieving the purposes and upholding the principles of the Charter of the United Nations;
- current system-wide delivery and financing of, and existing gaps in, technical assistance and capacity-building that support the implementation by States of their international human rights obligations and commitments;
- human rights implications of the lack of affordable, timely, equitable and universal access and distribution of COVID-19 vaccines and the deepening inequalities between States;
- impact and repercussions of measures taken by Governments in response to the COVID-19 pandemic on the safety and work of journalists and media workers;
- impact of the civilian acquisition, possession and use of firearms by children and youth;

- measures taken to implement Human Rights Council resolution 9/8 and obstacles to its implementation, including recommendations for further improving the effectiveness of, harmonizing and reforming the treaty body system;
- normative standards and obligations under international law in relation to the promotion and protection of the human rights of older persons;
- question of the realization in all countries of economic, social and cultural rights;
- rights of the child and family reunification.

■ The Council will consider reports from, and hold interactive dialogues with, **21 Special Procedures** (seven country-specific and 14 thematic), including those dealing with: adequate housing; albinism; counter terrorism; cultural rights; environment; food; freedom of religion or belief; foreign debt; human rights defenders; minorities; persons with disabilities; privacy; sale of children; torture; Cambodia; Democratic People’s Republic of Korea; Eritrea; Iran (Islamic Republic of); Mali; Myanmar; and Occupied Palestinian Territory. In accordance with **HRC/PRST/OS/13/1** all the Interactive Dialogues (IDs) will be individual.

■ In addition, the Council will also hold interactive dialogues with a number of **investigative mechanisms**, including the Commission on Human Rights in South Sudan, the Fact-Finding Mission on Venezuela, the Commission of Inquiry on the Syrian Arab Republic.

■ The Council is expected to act on between 32 and 35 draft resolutions and other texts. The deadline for submitting draft resolutions has been set at **1 PM on 23rd March 2022**. Additionally, it is expected to appoint **11 new mandate-holders**, including the Special Rapporteur on the promotion and protection of human rights in the context of climate change, Special Rapporteur on the situation of human rights in Afghanistan, Special Rapporteur on the situation of human rights in Burundi, Special Rapporteur on the situation of human rights in the Occupied Palestinian Territory, three members of the Expert Mechanism on the Rights of Indigenous Peoples (from Central and Eastern European States, Central and South American States, and Pacific States), one member of the Working Group on Arbitrary Detention (from Western European and other States), one member of the Working Group on Enforced and Involuntary Disappearances (from Asia-Pacific States), one member of the Working Group on the issue of human rights and transnational corporations and other business enterprises (from Asia-Pacific States), and one member of the Working Group on the use of mercenaries (from Latin American and Caribbean States). # IMPACT OF THE SPECIAL MEASURES TO COMBAT COVID-19 DURING THE HRC

In view of the ongoing COVID-19 pandemic, the extraordinary modalities utilised during HRC47 and HRC48 are expected to continue in full respect of the Institutional Building (IB) package and in compliance with the current health assessment and measures imposed by the Swiss Federal Council related to the prevention of the further spread of COVID-19.

These extraordinary modalities include:

- HRC49 will take place in **Room XIX**.
- During the **High-Level Segment**, dignitaries can be accompanied by maximum two persons. Dignitaries will have the opportunity to deliver their statements either in person or through prerecorded video statements.
- Outside of the High-Level Segment, access to Room XIX will be limited to **one person per delegation**. Throughout the 49th Session, State delegations would have the possibility to deliver their statements in person, through prerecorded video statements, or by using Zoom.
- All participants to HRC49 are requested to be accredited via **INDICO<sup>3</sup>** regardless of whether participating in person or not. When submitting an accreditation request, delegates are requested to indicate if they already possess an annual or temporary grounds pass at UNOG and, if so, are requested to upload a picture of the grounds pass in the relevant field of the INDICO platform. It is mandatory for all participants to provide a valid phone number.
- Video messages will have to be uploaded through the **online registration system** (<http://spreg.ohchr.org/>), which will open on 22 February at 4 PM, and will close 24 hours before the start of the meeting in which the debate is scheduled to start. However, delegations can still inscribe or annul their inscription by email ([ohchr-hrclistofspeakers@un.org](mailto:ohchr-hrclistofspeakers@un.org)). The deadline to upload video statements is at least two hours before the start of the debate for which they are submitted.
- **Special Procedures, members of investigative mechanisms, and panelists** who are unable to travel to Geneva are strongly encouraged to send pre-recorded video messages.
- When registering for **panel debates**, States will be asked to rank the panels in the order of their priorities, with the allocating of speaking slots happening accordingly. Should the number of States indicating the highest priority for a particular panel exceed the maximum number of speaking slots available, the slots shall be allocated on a first-come, first-served basis.
- **NGOs** in consultative status with ECOSOC and National Human Rights Institutions (NHRIs) with A status will be able to **deliver their statement in person** in Room XIX or via pre-recorded video-statements for all interactive dialogues, panel discussions, and UPR adoptions. Video messages will have to be uploaded directly through the online registration system (<http://ngoreg.ohchr.org/>). The deadline to upload video messages is at 6pm on the day prior to the debate for which they are submitted.

- NGOs in consultative status with ECOSOC and NHRIs with A status are invited to deliver their statements for the **General Debates** via pre-recorded video-statements only.
- Representatives wishing to **raise points of order** when not in the room may alert the Secretariat by using the **'raise hand' function on Zoom**. The Chair would then stop the debate and give the floor, through the Zoom platform, to the delegation that has raised the point of order.
- Representatives wishing to exercise their **right of reply remotely** may do so by sending a request to [hrclistofspeakers@ohchr.org](mailto:hrclistofspeakers@ohchr.org). They will receive an invitation to a video call five minutes prior to the moment that the right of reply would be exercised. The Secretariat will test the connection to ensure that sound and video are working. The representative will be able to follow what happens in Room XIX via the platform and will hear when they are given the floor. At that point, the representative can begin the intervention.
- In accordance with the IB package, **at least one informal open-ended consultation** will need to be held on each draft resolution and/or decision before it is considered for action by the Council.
- The main sponsors of draft resolutions are invited to organise **informal meetings virtually or in person** in Room XXI. Delegations can write to the **relevant focal point of the Council Secretariat** ([mkumar@ohchr.org](mailto:mkumar@ohchr.org)) for assistance to set up virtual participation in the informal rooms via the platform WebEx. If informal consultations are organised virtually, Core Groups should notify the HRC Secretariat in order for the meeting to be included in the online application **"Sched"**.
- **Side-events** cannot take place inside of the Palais des Nations during HRC49 due to the ongoing construction related to the Strategic Heritage Plan. However, virtual side events can be listed on the **Extranet** for information purposes.

# PANEL DEBATES

The 49th session is scheduled to hold seven panel debates and one thematic meeting on the following subjects:

- Annual high-level panel discussion on human rights mainstreaming - the contribution of universal participation to the mainstreaming of human rights throughout the United Nations system on the occasion of the tenth anniversary of the Voluntary Technical Assistance Trust Fund to Support the Participation of Least Developed Countries and Small Island Developing States in the Work of the Human Rights Council (28th February)
- Meeting on enhancing technical cooperation and capacity-building in promoting and protecting the human rights of persons in vulnerable and marginalized situations in recovery efforts during and after the COVID-19 pandemic (7th March)
- Annual full-day meeting on the rights of the child - the rights of the child and family reunification (9th March)
- Panel discussion on ensuring equitable, affordable, timely and universal access for all countries to vaccines in response to the COVID-19 pandemic (10th March)
- Annual interactive debate on the rights of persons with disabilities - statistics and data collection under article 31 of the Convention on the Rights of Persons with Disabilities (14th March)
- Panel discussion on the importance of robust public policies and services for the protection of economic, social and cultural rights in contributing to the COVID-19 pandemic recovery (22nd March)
- Debate in commemoration of the International Day for the Elimination of Racial Discrimination - voices for action against racism (28th March)
