## BACKGROUND INFORMATION

Enhancing the role of parliaments in the protection and realisation of human rights is an emerging issue, and several parliaments around the world have started to prioritize human rights and engage with the UN human rights mechanisms, including the UPR. Various resolutions have been passed by the Human Rights Council in relation to Parliaments and human rights. In its latest resolution (35/29), the Council acknowledged the crucial role that Parliaments play in translating international commitments into national policies and laws, especially the recommendations supported by the State in the framework of the universal periodic review and hence their contribution to the fulfilment of its human rights obligations and commitments. The UN Secretary-General has encouraged a more proactive engagement of parliamentarians in the work of international human rights mechanisms, including through the development of principles that would assist and guide them. Parliaments are uniquely positioned to contribute to closing the implementation gap. Indeed, within the context of the universal periodic review, over 50% of recommendations require or involve parliamentary action.

OHCHR in consultation with the IPU conducted a survey on parliaments and their engagement with human rights, pursuant to human rights Council resolution 35/29. A questionnaire was sent out to parliaments and other stakeholders and sixty-five responses were received. The replies received provided a useful overview of current practices of parliamentary human rights committees around the world, describing their engagement with UN human rights mechanisms.

## OBJECTIVES:

The overall purpose of the side event is to increase parliamentary engagement with human rights and, specifically to:

- Highlight the findings of OHCHR report prepared, in close cooperation with the IPU, on “Contributions of Parliament to the work of the Human Rights Council and its universal periodic review”, including the results of the survey; the role of parliamentary committees on human rights and the draft Principles on Parliaments and Human Rights;
- Consider the concrete experience of three/four senior MPs in terms of their parliaments’ human rights engagement, in particular at committee level;
- Share good practices on parliament’s engagement with human rights and possible next steps.

## EXPECTED OUTCOMES

- Sharing of existing good practices of parliamentary engagement with human rights from MPs from different regions of the world;
- Increasing awareness of on-going efforts to establish or strengthen national parliamentary human rights committees in line with the recommendations contained in A/HRC38/25.

## FORMAT/PROGRAM

The side event will involve a substantive panel discussion on different topics, drawing from good practices of various worldwide parliamentary systems and reflecting on the Draft Principles. The following topics will be discussed:
